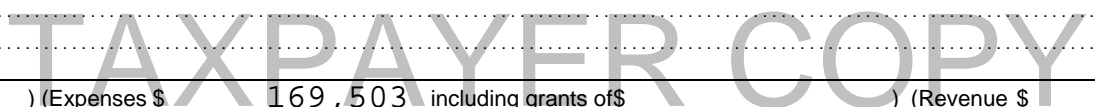

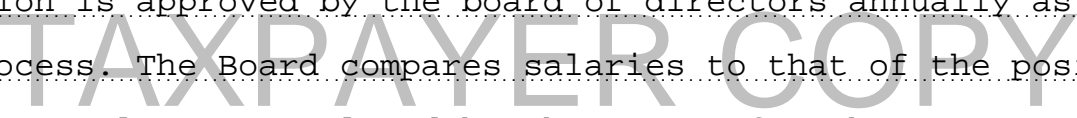
The board members annually sign the conflict of interest policy stating that they are not aware of any conflicts.
